Power Wheel Demo Derby Entry and Release Form Event Rules:

Pre-registration/ registration is free before April 12, 2019. If registering the day of there will be a \$10.00 charge to enter the power wheels demo derby. The power wheels derby will be held during intermission of the demo derby. Parent must provide cars and helmet for the kids that are participating in the Power wheels derby.

There will be 2 classes: Ages 4-6 and Ages 7-10. There will be a 1st, 2nd, and 3rd place in each age group and 1 hard luck award. All participants will receive a prize.

Check in: Children and cars can be checked in starting at 4:00- 6:30 pm at the tent in the back of the arena (power wheels pit tent). All cars must stay in the power wheels pit area the entire night unless they are in the arena or going home.

Safety: All children must wear approved safety helmets. Bicycle helmets are acceptable. If the child gets out of the power wheel during the event, that child is out of the event.

Power Wheel Build: All power wheels must remain stock with no added reinforcements. You may add duct tape to the tread area of the power wheel's tire for added traction. The motor must remain stock. The only modification you may use and will be allowed is using a 12-volt lawn mower battery.

Power Wheel Decorations: Power wheels may be decorated to look like a demo derby car, but can NOT have reinforcement. Decorations can only be made out of the following: cardboard, poster board, tape, paper, etc. Each power wheel must have a number on one side for scoring.

Keep in mind this is fun for the children!

Power Wheel Event Each age group will be given a 7-minute time limit. One parent must be in the designated area provided on the track during the time their child is in the arena. After time has expired, the winner that performed best during the heat will be scored by the judges. Judges will be randomly chosen by the WCFA.
